Public Forum:

Mr. Chet Miles, 621 Meadowview Court, wanted to thank Council and the Village Staff for coming to the Villas of Timber Ridge Homeowners Association Meeting that was held last week and informing the residents about the upcoming ballot issue. Mr. Miles stated that the residents enjoyed it and the feedback that he has received has been positive and he felt it was very beneficial. Mr. Miles also wanted to address the topic of allowing liquor to be sold by the glass in Carlisle. Mayor Winkler thanked Mr. Miles for coming to the Council meeting tonight and stated that the Village would be open to making the Town Hall building available for their Homeowners Association meetings in the future and the Village would do its best to accommodate them. Mr. Miles stated that they would be having their next meeting in the spring. Mr. Licklitter stated that Council would be happy to attend these meetings in the future if Mr. Miles would like.

Council Report:

Mr. McIntosh thanked the citizens who attended the recent ballot issue meetings. Mr. McIntosh reminded residents that on Saturday, November 15th, there will be a 5K race in Carlisle to benefit the Allistrong Foundation. Mr. McIntosh stated that it is a great local organization and that he will be running in the race.

Mrs. Parr stated that Trick or Treat night will be Thursday, October 30th, so be on alert for children on that evening. Mrs. Parr reminded residents to exercise their right to vote on Tuesday, November 4th. Mrs. Parr suggested that a discussion on selling liquor by the glass should be pursued in a future work session or at the upcoming Council retreat.

Mr. Licklitter stated there was a Finance Committee Meeting that was held after the last Council meeting and a first review of the 2015 budget was discussed. Mr. Licklitter stated there will be a 3rd Quarter review after Council meeting this evening. Mr. Licklitter said the next budget review will be at a work session on November 12th at 7:00 p.m.

First Reading of Ordinances and Resolutions:

ORD 12-14: AN ORDINANCE AUTHORIZING THE TRANSFER OF \$60,000 FROM THE GENERAL FUND (101) TO CARLISLE BUSINESS PARK FUND-302.

Mrs. Callahan stated these next four pieces of legislation are fund transfers that begin the year end cleanup and need to be done by separate ordinances. Mrs. Callahan stated that this ordinance transfers money from the General Fund to the Business Park Fund in order to pay down the Business Park debt.

With no further discussion, Mayor Winkler stated that this legislation would be presented for a second reading at the November 12th meeting.

ORD 13-14: AN ORDINANCE AUTHORIZING THE TRANSFER OF \$55,000 FROM THE EAGLE RIDGE TIF FUND (210) TO SR 123 FUNDS 412, 413, 414, AND 415.

Mrs. Callahan stated that this legislation is the Eagle Ridge TIF fund transfer payment to pay debt on SR 123 Phases 4-7.

With no further discussion, Mayor Winkler stated that this legislation would be presented for a second reading at the November 12th meeting.

ORD 14-14: AN ORDINANCE AUTHORIZING THE TRANSFER OF \$21,600 FROM THE WATER FUND (603) TO WATER CAPITAL IMPROVEMENT FUND (425).

Mrs. Callahan stated that Council established a water capital improvement fund earlier in the year. All tap-in fees go into this new fund. The new fund needed approval from the state of Ohio, which we recently received. This legislation is to transfer all year to date fees from the water fund to the water capital fund.

With no further discussion, Mayor Winkler stated that this legislation would be presented for a second reading at the November 12th meeting.

ORD 15-14: AN ORDINANCE AUTHORIZING THE TRANSFER OF \$6,000 FROM THE PARKS CAPITAL IMPROVEMENT FUND (404) TO GENERAL FUND (101) FOR THE REPAYMENT OF AN FY2013 ADVANCE.

Mrs. Callahan stated that this legislation is a repayment to the general fund to the park fund. The Village waited on a reimbursement from a grant which we have received.

With no further discussion, Mayor Winkler stated that this legislation would be presented for a second reading at the November 12th meeting.

Second and Third Readings of Ordinances and Resolutions:

ORD 11-14: AN ORDINANCE PROVIDING FOR THE ISSUANCE OF \$563,700 VARIOUS PURPOSE BOND ANTICIPATION NOTES, TWELFTH (2014) RENEWAL, BY THE MUNICIPALITY OF CARLISLE, OHIO IN ANTICIPATION OF THE ISSUANCE OF BONDS.

Discussion: Mrs. Callahan stated that this is the annual pay down for the Business Park infrastructure note.

With no further discussion, Mr. Licklitter made a motion to adopt, seconded by Mr. Fryman.
