Public Forum:

Warren County Career Center – Cathy McMonigle and Dave Siebert

Mrs. McMonigle said that Superintendent Joel King could not make it this evening, but the two of them have come in his place. Mrs. McMonigle introduced herself as the Warren County Career Center Treasurer along with Dave Siebert who is the Director of Maintenance and Facilities. She thanked the council for allowing them to come speak to them about their bond and tax issue on the ballot this March. She said even though Carlisle is not one of their feeder schools. Carlisle already had an arrangement with Miami Valley before the Warren County Career Center being built, not making it one of the six feeder schools. She said they do serve Carlisle students when they're capable and they have in the past. She said there may be residents who live within the area or might know somebody and there are other ways they serve Warren County, adult education, and workforce development so they wanted to come speak with the council tonight. She said they are asking for a bond and a permanent improvement issue this March. They are in an Ohio Facilities Commission Opportunity to build a new building. Part of the reason that this is important to them is [inaudible] the County back then has quadrupled since the building was originally built. [Inaudible]. Last year the applications for programs were about 800 applications [inaudible]. Sometimes they cannot provide an opportunity for them to get in. They want to increase their student capacity. [Inaudible].

Mr. Faulkner asked what percentage the state is paying. Mrs. McMonigle said about a quarter percentage. Mr. Faulkner confirmed they were going to raise the rest of it for less than a mil. Mrs. McMonigle said yes. Mr. Faulker said that is an easy one to vote for and thanked them for telling the council about it. Mrs. Kemper thanked them as well and said the main thing is to get the word out to all the voters because they need to know how important this is. Mrs. Kemper wanted to make sure that any Carlisle student could put their application in, as well. Mrs. McMonigle said absolutely. She said there is a lottery and priority given to their home school students. It goes off the date of when you get your application in and whether you belong to one of the home schools or outside the area. She said there is still an opportunity to attend if their program is not full. Superintendent King, this is only his second year, he has started [inaudible]. Mr. Kilpatrick thanked them both for joining us.

First Reading of Ordinances and Resolutions:

RES NO 8-24 APPROVING A THEN-AND-NOW CERTIFICATE

Mr. Lohr asked Mrs. Cooper to discuss this ordinance, along with Resolution 9-24.

Mrs. Cooper said both were brought for approval because the invoice was received prior to encumbrance and is greater than \$5,000. Mr. Lohr said for these, they are not sure why, but we did not receive invoices from Warren County Water and Sewer for almost two full years. We just got those for 2023 and 2022 and we were not anticipating that and that's why they are here tonight. Mr. Faulkner asked what we use them for. Mr. Lohr said we use them for some sewer services and that is primarily it. Mr. Faulkner asked if we were at the end of then and now certificates. Mr. Lohr said it is not something we like to do, but in this case, we did not expect it. Even looking back at the budget for figuring out what we needed to appropriate, we had not paid that going back to 2022. Mr. Kilpatrick said it looks like a slip up on their end. Mayor Winkler said he thinks Warren County does most of the work on the lift stations. Mr. Lohr agreed. Mr. Faulkner asked if we had talked to them about getting invoices in a timely fashion. Mr. Lohr said we have not, but certainly will. Mr. Humphries said he appreciated the opportunity not to have it as an emergency.

A RESOLUTION APPROVING A THEN-AND-NOW CERTIFICATE IN THE AMOUNT OF \$17,154.12 TO WARREN COUNTY WATER AND SEWER DEPARTMENT FOR THE 2023 SHARED FACILITIES MAINTENANCE AND OPERATIONS AGREEMENT.

Mr. Stivers said on the agenda introduction sheets for both 8-24 and 9-24 they are recommended as an emergency. Mr. Lohr said that was his mistake, but what we are doing here with a first reading is correct.

ORD 6-24 AMENDING CITY CODE 236.09

Mr. Lohr asked Mrs. Cooper to discuss this ordinance.

Mrs. Cooper said this is requesting an update to the code to allow for the capital asset. It is currently at \$5,000 and in two years she would like to increase that to \$10,000, as we start implementing the fixed asset software. Mr. Faulkner asked if she wants to expense everything below \$10,000 and to capitalize anything over \$10,000. Mrs. Cooper said \$10,000 or more. Mr. Faulkner asked why she wants to raise it and if she wants less capital items in her software. Mrs. Cooper said it is the recommended levels from the GFOA, the Government Finance Officers Association. Mr. Faulkner said if he understands it, she has new software, but now less things to track because less things will be over \$10,000. Mrs. Cooper said correct.

ORD NO 7-24: ADOPTING THE PAY PLAN FOR THE CITY OF CARLISLE

Mr. Lohr said this is a follow-up to their discussion from the last work session about adding a full-time administrative clerk to help with permitting, tax payments and utility payments. Mr. Faulkner said Mr. Lohr said \$60-70,000, but how much of that is healthcare because all the rates were in the legislation, but he never said what that position is going to pay. Mr. Lohr said it is our lowest pay scale. He can pay anywhere in the pay scale, but he anticipates being on the bottom end, in the \$18-21 an hour range. He anticipates an additional 50% for benefits, which is a spitball number. It really depends on whether they need family or single coverage, which is the biggest difference in pay. Mr. Faulkner said experience does come into play too. Mr. Lohr said yes. Mr. Lohr said when we are talking about permitting, the largest volume is in the middle of the summer months so he is requesting this is a single reading so he can get this person hired and trained, and hopefully up to speed, by the time we hit that peak volume for applications.

Mayor Winkler asked for a motion to suspend the rule requiring three readings, have one reading by title only. Mrs. Kemper made a motion, followed by Mr. Faulkner.
