



**2024 LOCAL MOBILE FOOD VENDING (FOOD TRUCK) APPLICATION**

Application is hereby made for a LOCAL MOBILE FOOD VENDING PERMIT as required by ORD. 19-20 of Carlisle Village Council. The applicant understands and agrees that:

Initial

- \_\_\_\_\_ Vehicle will be placed only upon a commercial or manufacturing zoned lot with frontage on SR123 and direct drive access to SR123 or upon Municipal-owned parks or property.
- \_\_\_\_\_ Written permission of property owner allowing use of mobile vehicle on property must be provided to Village no less than 48 hours before placement of vehicle on property.
- \_\_\_\_\_ Service will only be provided between the hours of 8:00 a.m. and 8:00 p.m.
- \_\_\_\_\_ Vehicle must be placed on an approved surface with available on-site parking and access drives.
- \_\_\_\_\_ Vehicle will not be placed closer than 150' from existing restaurant (without waiver of restaurant owner) or closer than 100' from any residential zoned district.
- \_\_\_\_\_ Vehicle will only sell food or non-alcoholic beverages (no merchandise or retail sales).
- \_\_\_\_\_ Trash receptacle will be provided not more than 10' from vehicle.
- \_\_\_\_\_ Any sound emanating from vehicle shall not be loud enough to create a disturbance to abutting property owners.
- \_\_\_\_\_ Maximum of 1 portable sign per vehicle with maximum sign height of 3'. Sign cannot be placed closer than 10' from the right of way and not impede vehicular or pedestrian traffic.
- \_\_\_\_\_ Vehicle must be attended at all times. Vehicle and portable sign must be removed from property when business is not in operation (no overnight parking permitted).
- \_\_\_\_\_ Permit is non-transferrable and is valid only for the vehicle information contained in application.
- \_\_\_\_\_ Copy of Local Mobile Food Vending permit and valid food service license must be kept on vehicle at all times.
- \_\_\_\_\_ Copy of valid food service license is attached to application.
- \_\_\_\_\_ Applicant has received a copy of ORD. 19-20 and agrees to abide by the required standards and regulations.
- \_\_\_\_\_ Non-refundable fee of \$75 included with application. Annual permit shall expire on December 31st.
